Some agencies that participate are City of Harlingen, the Harlingen Consolidated Independent School District (HCISD), Jubilee Academy, Idea Public Schools, Southern Career Institute (SCI), NINOS Head Start Services, the Harlingen Boys & Girls Club, Job Corps, Driscoll Health Plans, MHP Salud, APC Homemaker Services, and others that are willing to donate school supplies such as backpacks, paper, pens, pencils, rulers crayons, markers, and other items needed by children to return to school.

**The Book Rich Environment (BRE)** book distribution is held at Market Days on Jackson Street. The Harlingen Housing Authority in partnership with the Harlingen Affordable Housing Corporation (HAHC) distributes free brand-new books to children during the Saturday Market Days event. Children can select the book they want from the selection of books provided by our Housing Authority. We provide free books for different age groups such as infants, toddlers, school age children, and teenagers. We distribute approximately 200 books, each Saturday during the Market Days event. The goal of the BRE Initiative is a collaboration aimed to transform Housing Authorities into book rich environments by providing diverse, high-quality books, and other literacy tools to children and families with limited resources.

**Market Days on Jackson Street in Harlingen, Texas** is an event that was established by the City of Harlingen and the Harlingen Downtown District. We invite everyone to join us every 1st Saturday of the month. Looking forward to seeing all of you soon.

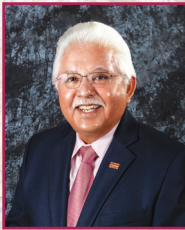

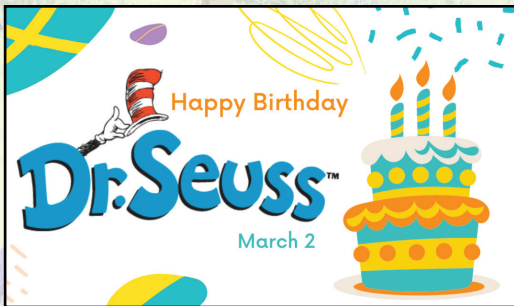
**Le Moyne Gardens Apartments** – 3221 N. 25th Street, Harlingen, Texas 78550

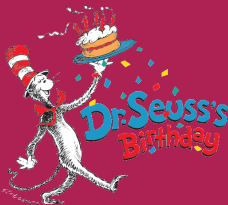

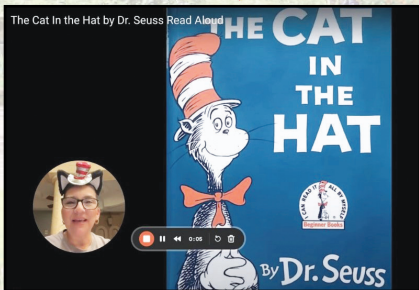

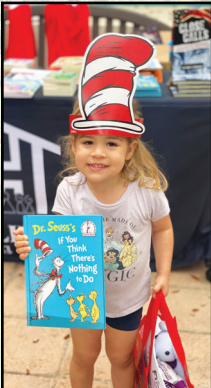

## HOUSING CHOICE VOUCHER / SECTION 8 PROGRAM (HCV/S8)

Hello everyone! We hope everyone is enjoying Spring! *"Don't wait for someone to bring you flowers. Plant your own garden and decorate your own soul."* — Luther Burbank  
 Inspections play a large and important role in the Housing Choice Voucher (HCV) Program. Inspections are required by HUD and take place annually throughout tenancy. The purpose of inspections is to ensure that decent, safe, and sanitary housing is available for families.

### TYPES OF INSPECTIONS:

**Initial/Move-In Inspections:** The PHA conducts an initial inspection to approve a unit for participation in the HCV program. The unit must pass the inspection before any Housing Assistance Payments can be paid to the owner. Therefore, it is best if the family does not move into the unit before approval.

**Annual Inspections:** HUD requires the PHA to inspect each unit under lease annually to confirm that the unit continues to meet criteria. The inspections may be conducted in conjunction with the family's annual reexamination but is typically conducted before.

**Special Inspections:** A special inspection may be requested between annual inspections by the owner, the family, or a third party because of problems identified with a unit between annual inspections.
